This is the only video I have.

Please advise when I can expect to hear back from you or someone else about the explanation for the officers' insouciance. I am not prepared to wait very long. It would be remarkable if an I.A. investigation into the officers' conduct had not taken place long ago, and I assume that the only discussions currently



at issue are what I am to be told. If I am incorrect and there has been no inquiry, please accept this as a request for an immediate and prompt investigation.

May I hear back from you before the end of this week, please, with a substantive response or, that failing, a firm schedule including a target date for a substantive response.

Please let me know when I can expect to hear from you (or the Police Department) about the almost-drowning incident that I raised with you a month ago. I understand from you that you have the complete video, from the time Mateusz walked into the water until the time that the EMTs showed up, so I am not forwarding it to you.

To be clear, what I request on behalf of my client is a cogent explanation for the insouciant behavior of half a dozen or so Fairfax officers as Mateusz nearly drowns in their presence. And things being what they are these days, after the John Geer stonewalling and more recently the Bijan Ghaisar stonewalling (the latter not by your client), I cordially request to be informed promptly if there will be a delay of, say, more than ten more days before I receive a substantive response. The incident happened half a year ago. I assume -- certainly hope, for the sake of the department and the residents it serves -- that police brass promptly caused this incident to be investigated. So I assume that all that is being considered at this time is not how to investigate this matter but whether to release the results to me, in however summary or sanitized a fashion. Given the intervening holidays it has made sense to wait, but now that we are all back at work, it seems appropriate for us to move forward. How we do so, at this point, is largely up to your clients.
