Declaration of Thomas Guglielmo

- I, Thomas Guglielmo, declare under penalty of perjury that the following is true:
- 1. I am Associate Professor of American Studies at George Washington University. My research, writing and teaching focus is on American racial and ethnic history. My curriculum vitae, attached as Exhibit 1, sets forth my professional background and work.
- 2. I have researched, taught and written about the Virginia Racial Integrity Act of 1924, including the role of Walter Plecker, registrar of the state's Bureau of Vital Statistics from its inception in 1912 until 1947. Consumed by the fear that "racial amalgamation" would contaminate white "purity" and imperil the nation, Plecker helped pass a series of strict state segregation laws in the 1920s, most notably the Virginia Racial Integrity Act of 1924, which made it "unlawful for any white person ... to marry any save a white person." He also made it his personal mission to enforce these laws by determining and recording all Virginians' "proper" racial status. He hoped to detect the thousands who "possess an intermixture of colored blood, in some cases to a slight extent, it is true, but still enough to prevent them from being white"—and from legally marrying and mixing with whites in schools, hospitals, theaters, and other public places. Seeking any evidence of nonwhite status, he interviewed prominent white state residents and mined nineteenth-century county and federal records, including birth and death certificates, taxpayer lists, and U.S. census reports. He also closely monitored all the state's midwives, doctors, undertakers, and local registrars and explicitly, sometimes coercively, instructed them how to classify people racially on birth, death, marriage, and divorce certificates, always demanding overwhelming "proof" of whiteness. He even sought, with mixed success, to

convince U.S. census enumerators in 1930 and again in 1940 to follow his preferred racial classification schemes.

3. The foremost book-length study of American miscegenation laws is *What Comes Naturally: Miscegenation Law and the Making of Race in America* (2010), by the late Peggy Pascoe. Pascoe's book is recognized as reliable authority in its field. Pages 140-50 (with the attendant footnotes) of Pascoe's book address Virginia's Racial Integrity Act of 1924. I understand that counsel is making the book available as needed in litigation regarding the requirement that applicants for a marriage license in Virginia state their race.
