Preliminary and Jurisdictional Statement

1. Plaintiff Mohamed Salim is an American citizen, a sergeant in the United States Army Reserves and a veteran of the Army's fight against terrorists in the Middle East. He is an Arab and a Muslim. He drives a taxicab for a living. In April 2013, he picked up defendant Dahlberg, who needed a ride home. During the ride, defendant Dahlberg questioned him about his beliefs, accused him of being a terrorist, denounced him and all Muslims and Arabs in a grossly outrageous manner, punched him, and left his cab without paying. Defendant Dahlberg's vitriol was captured by Mr. Salim's cell-phone, which he turned on once it became apparent that defendant Dahlberg was deranged and threatening. Mr. Salim now sues defendant Dahlberg for racial discrimination in contracting under federal law, for committing a hate crime under state law, and for common law assault, battery, and intentional infliction of emotional distress. This case arises under 42 U.S.C. §1981 and the court has jurisdiction over it under 28 U.S.C. §1331. The court has supplemental jurisdiction over the state law claims, which arise out of the identical facts.

Parties

2. Plaintiff Mohamed Salim is an American citizen since 2008 and a veteran of the United States Army's fight against terrorists in Iraq. He is an Arab and a Muslim. He drives a taxicab for a living. He is 40 years old.

3. Defendant Edward Dahlberg is a resident of Clifton, Virginia. He is president of Emerald Aviation, Inc., a Virginia corporation. He is an avowed racist and bigot.

Claim for Relief

4. Around or shortly after midnight, April 26, 2014, Mr. Salim was called to the Fairfax Country Club to pick up a passenger who needed a ride home. This was defendant Dahlberg, although Mr. Salim did not know his name and had never seen him before.

5. Mr. Salim speaks English with an Arabic accent deriving from his upbringing in Somalia, where he was born.

6. At some point during the ride to his house, defendant Dahlberg asked Mr. Salim where he was born. On learning that he was born in Somalia, Defendant Dahlberg embarked on an increasingly out-of-control series of statements, demands, insults and threats directed at Mr. Salim.

7. Mr. Salim responded calmly and professionally to Defendant Dahlberg's escalating abuse. At a certain point, however, he undertook to turn on his cell-phone's audio recording function, so as to capture Defendant Dahlberg's increasingly vehement ranting. When even this escalated, he turned on his phone's video function and informed Defendant Dahlberg that what he said was being recorded.

8. The verbatim presentation of the recorded colloquy between Messrs. Salim and Dahlberg is set forth in the transcript attached to this complaint as Exhibit A, which transcript is incorporated by reference into this complaint as though set forth in its entirety herein.

9. The audio and video of Defendant Dahlberg's verbal abuse and of one incident of his striking Mr. Salim appears on line on You Tube at <Salim v. Dahlberg> or

<<u>https://www.youtube.com/watch?v=NnGvBqWzXlY&feature=youtu.be</u>>. The content of this video is incorporated by reference into this complaint as though set forth in its entirety herein.

10. Defendant Dahlberg graced Mr. Salim, and Muslims and Arabs in general, with the following encomiums among others:

- * I am judging you. You fucking radical fuckers are fucking blowing people up all over the world.
- * If you're a Muslim, you're a fucking jihadist.
- * Your Koran says you must kill non-believers. *** I'm fucking serious as a heart attack.
- [D]enounce those fucking assholes that flew jets into the World Trade Center. Tell me that they are pieces of shit or you are with them.
 SALIM: Are you prejudiced?
 DAHLBERG: Fucking A I am.
- I will slice your fucking throat right now.
 SALIM: You say you're threatening me?
 DAHLBERG: Fucking A.
- * Tell me you denounce those motherfuckers now, that you're one of them and you're a fucking terrorist.
- * I don't give a fuck if I know you. I'm asking you the simple question. And you can't answer it. Because you are a fucking Muslim terrorist just like the rest of them.

- Fuck Jihad. Fuck all that fucking Muslim shit.
 SALIM: Okay. Just speak peace and sit please.
 DAHLBERG: Fuck you. Fucking peace. You're a piece of shit. You're just as bad as the rest of them.
- * SALIM: [N]ow you're punching me, right? You punching me, right? Why you punching me?
 DAHLBERG: Fuck you.
 SALIM: Why you punching me? Sir, why you punching me?
 DAHLBERG: Because you're a shit Muslim.
- 11. Defendant Dahlberg then got out of Mr. Salim's cab without paying.

12. As a result of Defendant Dahlberg's verbal and physical assault, Mr. Salim suffered physical injury in the form of a hairline fracture of a bone in his face where Defendant Dahlberg punched him, as well as serious and ongoing emotional distress. He received prompt emergency care for his face, and thereafter commenced a course of counseling with a mental health therapist. He was also denied the fare for having driven Mr. Dahlberg in his cab.

13. Defendant Dahlberg's assault and battery on Mr. Salim were provoked by Mr. Salim's being Arab and Muslim. They constituted unprovoked, outrageous aggression motivated by hate. Defendant Dahlberg's malevolance is not subject to being minimized or explained on the theory that he had been drinking, as alcohol facilitates rather than causes speech; in addition there exists unrelated on-line references to his prejudice. Defendant Dahlberg's verbal and physical threats and assaults were willful, intentional, malicious, outrageous, in violation of Mr. Salim's rights and of acceptable standards of behavior, and intended to inflict severe emotional distress upon Mr. Mohamed, which they did.

Causes of Action

Count I: Violation of 432 U.S.C. §1981

14. By securing Mr. Salim's services as a taxi driver, defendant Dahlberg entered into a contractual relationship with him whereby in exchange for driving defendant Dahlberg home, Mr. Salim would be paid his posted fare. This contractual agreement also included, as a condition implied by law, that the parties would deal with each other fairly and in good faith so as to permit the successful consummation of the agreed contractual purpose. By directing outrageous verbal abuse at Mr. Salim, by threatening his life and safety, by physically attacking him, and finally by leaving his cab without paying, all as set forth above, and all because of his open hatred of Arabs and Muslims, defendant Dahlberg violated Mr. Salim's right to contract freely and to benefit from the terms and conditions of a contract without regard to race and without racial discrimination, in violation of 42 U.SC. §1981.

Count II: Violation of Virginia Hate Crimes Act

15. By his actions set forth above, defendant Dahlberg committed a hate crime against Mr. Salim, in violation of *Code of Va.* §8.01-42.1.

Count III: Assault

16. By his actions set forth above, defendant Dahlberg assaulted Mr. Salim.

Count IV: Battery

17. By his actions set forth above, defendant Dahlberg committed battery against Mr. Salim.

Count V: Intentional Infliction of Emotional Distress

18. By his actions set forth above, defendant Dahlberg intentionally inflicted emotional distress upon Mr. Salim.

Wherefore, Mr. Salim requests an order of the court granting him:

- * His actual damages in an amount appropriate to the proof at trial,
- * Punitive damages in an amount appropriate to the proof at trial,
- * His costs, including reasonable attorney's fees, and
- * Such other relief as is just.

Mr. Salim requests trial by jury.

Whatever you saying is 16 recorded and --17 Now you're punching me? You punching me? 18 DAHLBERG: Do you think it was proper for 19 the United States --20 SALIM: You -- you -- now you're punching 21 me, right? You punching me, right? Why you punching 22 me?
